No refunds or medical credits can be made except as described in the Pro-Rata and Refund Policy cited below. Unlimited golf is not guaranteed.

Platinum Membership Pro-Rata and Refund Policy:

1. Platinum Memberships shall be limited to two (2) people per household and are non-transferable.
2. Platinum Memberships will be pro-rated one time only for new home buyers unless approved by the Head Golf Professional.
 - a. New homebuyers have one (1) year from close of escrow to exercise this option unless executed early.
 - b. Resale homebuyers have one (1) year from close of escrow to exercise this option.
 - c. When applying for pro-rated fees, documents showing proof of purchase must be presented to QC Pro Shop
 - d. Platinum Membership fee may be pro-rated for new buyers if a play card membership has already been purchased. Play card memberships with the exception of the Bronze (summer annual) membership can be upgraded to a Platinum Membership within the first three (3) months of purchase and will be valued at the number of unused rounds remaining on the play card membership.
3. Platinum Memberships will be refunded in the event of purchaser's death. Refund of the decedent's fees will be pro-rated beginning with the first full month following the death.
4. Platinum Membership fees will not be pro-rated, refunded or credited for any other reason.

ACCESS

- Tee times are allocated using the Chelsea web based tee time reservation system which electronically places golfers onto the tee sheet based upon a weighted point system. The Quail Creek Pro Shop will reserve additional tee times on a year round basis for the Sales department, the Preferred Guest program, and public play. These reserved tee times, if not filled, will/may become available to the homeowners on the afternoon of the day prior to play.
- Promotional and charity golf outings will be held periodically at the discretion of Quail Creek Pro Shop. Unlimited golf access is not guaranteed. The golf course will be closed for overseeding operations and periods of inclement weather.
- Course closures and temporary disruptions in play caused by adverse weather conditions or maintenance operations create no obligation on Quail Creek for refunds, rebates, or credit in connection with all Memberships or Daily Fees.
- Golf course cart policy allows that no more than two carts to be used per foursome. Resident golf carts to be used on the facility must meet pre-determined specifications. (Exceptions may apply during unusual circumstances)

Quail Creek Pro Shop reserves the sole right to interpret these policies.

Applicant hereby waives, releases and forever discharges, and further agrees to indemnify, defend and hold harmless, owners of Quail Creek Country Club golf courses as well as its agents, owners, officers, directors, members, managers and affiliates (collectively the "Golf Course Affiliates") for, from, and against any and all liability, claims, damage or expense whatsoever arising from or otherwise relating to the use by Applicant and his/her guests of the Quail Creek Country Club golf courses (including any golf car thereon), except to the extent directly caused by the willful misconduct of such Golf Course Affiliate.
